

National Provider Identifier/New Paper Claim Form

Get your NPI (each Corporate Entity and each DC needs an NPI)

To Apply on line for a NPI go to the following web site:

Select: apply on line for an NPI

To request a paper application call 1-800-4653203 and ask for:

NPI Application Form # CMS-10114

Report it to Noridian (paper claim submitters do not need this step)

To report your NPI to Noridian Medicare EDI get an NPI Update Request form at:

Submit on line or mail NPI Update Request Form to: EDI Support Services

Note: If you have a corporate NPI

Report it to Participating Local Insurance Companies

To report your NPI to participating local insurance companies register your NPI with

OneHealthPort at: <http://onehealthport.com> select register

Electronic claims and paper claims submitters can register with OneHealthPort.

Many local insurance companies (Regence, Premera, GroupHealth, First Choice Health, The Everett Clinic, Providence Health System, HealthServicesNW and Swedish Medical Group) will download your NPI from OneHealthPort. OneHealthPort is a HIPAA health care partner, is very secure and is free for providers.

Use your NPI with your UPIN/GPIN until May 22 2007?

Medicare will allow paper claim submitters to continue using their UPIN on the old claim form (12/90) until further notice, however many local insurance companies may start using the NPI on May 23 2007 or soon after. Paper claims submitters will enter their UPIN in box 33b and their NPI in 33a on the new paper claim form CMS 1500 08/05.

Use only your NPI on E-bills and the new paper claim form on/after May 23 2007 ?

Sole proprietors (not incorporated) paper claims submitters will enter their NPI in 33a on the new form CMS 1500 08/05. Corporate paper claims submitters will enter their corporate NPI in 33a and their personal NPI in 24J.

New Paper Claim Form Alert ??????? Deadline

Paper claims submitters **may** use the new claim form CMS 1500 08/05 now. Since some new claim forms were incorrectly printed by the Government Printing Office, the old deadline (April 2 2007) has been set aside. Paper claims submitters may continue to use the old claim form with their legendary ID number until further notice.

Labor and Industries

You may use your old L&I provider number on the old claim form until June 1 2007. You may use your NPI or your old L&I provider number on the new claim form now. Before using your NPI for L&I call Provider Accounts and register your NPI at (360)9025140.
